- 1. **Opening Remarks** The AGM was opened at 1030 hrs with LCol Angell thanking everyone for their attendance.
- 2. **Review of 2017 CMT AGM Minutes** The previous minutes were circulated along with the agenda. The Ops Advisor asked for any errors or omissions.
- 3. **A motion** was made by WO Williams, **seconded by** MWO Babin, that the 2017 Ceremonial Mounted Troop Foundation minutes dated September 2018 be accepted as presented. CARRIED
- 4. **Foundation Operations Overview** CMT Foundation continues to be quite healthy. The main focus in 2018 was the Moreuil Wood 100th Anniversary celebrations in Canada and France and Pursuit to Mons.
- 5. The Troop continues to prioritize high value activities over smaller locations due to funding constraints (honourariums and inflation. It has seen an expanded role with Spruce Meadows to include Calgary FC (soccer club), however will be focusing on broadening its footprint in Edmonton in 2020.
- 6. The Troop is developing an ongoing recap program for higher cost items such as mounts and major equipment.

- 7. **2018 Financial Reports** Capt Peterson gave an overview of the audited 2018 Ceremonial Mounted Troop Foundation financial report that was circulated prior to the AGM.
- 8. The Foundation is healthy financially. It continues to look at ways to reduce expenditures.
- 9. **A motion** was made by MWO Shiells, **seconded by** Capt McTavish, to adopt the audited 2018 Ceremonial Mounted Troop Foundation 2018 audited financial statement as presented. CARRIED
- 10. It was asked if further progress has been made with applying for a separate Foundation casino. The Board is working towards ensuring a clear separation between Foundation and Society.
- 11. **Appointment of Auditor for 2019 A motion** was made by Capt Smith, **seconded by** Maj Timms, that Jay C. Noden Professional Corp be appointed as the 2019 auditor with remuneration being set by the Society Operations Adviser based on costs from the previous year. **CARRIED**

Annual Reports

- 12. **Board of Directors** The Board held four meetings throughout the year. It has focused on developing committee structure to support long term, health of the Foundation. The Governance and Legal Committee updated the Articles of Association. The Board, through the committees is developing a Policy and Procedures manual to allow for smoother updating of Board members and e-voting. The Board explored opportunities for engagement or relinquishing of Foundation membership responsibilities of regular members.
- 13. The Board remains committed to being transparent to members, government agencies and outside funders. Lots of attentions is going into ensuring that the right people are being recruited for the Board and committee positions.
- 14. The remaining funds from the Foundation's CFCF investments were re-invested at the close of 2018. The Foundation did apply for a separate casino through AGLC, but it was rejected.
- 15. **Strathcona Mounted Troop Report** Capt Giajnorio provided members with an overview of SMT steady state, 2018/2019 ride season, 2020 goals and areas of concern. See PowerPoint slides, which were distributed via email prior to the meeting.
- 16. The Troop is concentrating efforts to expand the SMT brand in Edmonton. Of note the City of Edmonton will be proclaiming SMT as their Official Colour Guard in early 2020. The Troop will not be available for Reunion 2020 due to SM commitments. They are continuing the procurement of steel arch saddles. An uptake of donations has been realized since recent publicity. The Foundation is looking to leverage grants for Boer War uniforms in preparation for 125th anniversary.
- 17. A motion was made by Maj Gray, seconded by MWO Holmes, to accept the 2018 annual reports as presented. CARRIED.
